- c. The bidder should be in business of supplying, installing, commissioning and maintaining ATMs/CRMs in Bangladesh for a period of at least 03 years.
- d. Product should be ready to deliver as per the following schedule. Part delivery allowed. Original copy of the certificated mentioned into Information to Tender point 17.7 must be supplied with each delivery of the ATMs/CRMs. Trust Bank PLC. may at its sole discretion change the required quantity up to maximum ±10%.

- e. Vendor must submit Q/C certificate with serial number with delivery of ATM & CRM.
- f. Vendor must attach a warranty sticker with ATM & CRM that should clearly mention warranty period of the product, delivery date, W/O No., Name & Address of the supplier with mobile number.
- g. Vendor must inform Trust Bank PLC. one month before the arrival of ATM & CRM at BD for inspection. Inspection shall take place at the site of vendor.
- h. The bidder shall be responsible for delivery, installation, testing & commission of the ATMs/CRMs ordered at all the sites and for making them fully operational at bidder's own cost.
- i. ATMs/CRMs offered should be capable of being fully integrated with the existing Trust Bank PLC. systems immediately on installation without any modifications/testing and providing the same functionalities as existing ATMs/CRMs installed by Trust Bank PLC.
- j. The ATMs/CRMs being procured through this offer shall be installed and commissioned by the bidder, at various locations (across the country) which shall be intimated separately.
- k. In the event of supply any item which do not match with the required terms & specification, the bank reserves the right for outright rejection of the goods and the supplier will have to take back those at their own cost and will replace with bank demand.
- 1. Vendor shall be fully responsible for the manufacturer's warranty in respect of proper design, quality and workmanship of all equipment, accessories etc. covered by the offer.
- m. SLA should be executed by the bidder with the Bank within a period on or before the date of issuance of Work Order. The stamp duty for the execution of SLA shall be borne by the successful bidder.
- n. On expiry of Warranty, the Bank shall have the sole discretion to enter into an agreement with the existing or a new vendor for Annual Maintenance Contract (AMC) based on the quality/level of services extended by the vendor during the warranty period.
- o. The vendor must provide the original equipment and mention the country of origin. Product must be delivered from authorized channel.
